### **Definitions:**

Online Tutor-Led Courses (**OTLC**) – are open to anyone, paid for courses that have set registration dates and learning takes place on scheduled dates, and are offered fully online.

On Campus Open Courses (**OCOC**) – are open to anyone, paid for courses that have set registration dates, are delivered face-to-face on scheduled dates.

Additional Short Courses (**ASC**) - these will be occasional courses, usually delivered as part of a funded programme by the PSDF, NAVTTC, TEVTA or any Government, Local Authority or other funding programme, details of these ASCs will be set out on the Website with our other Short Courses but access to these may require you to accept additional Terms in order to comply with any applicable Funding Rules.

### **3. Applications**

We are free to accept or decline your Application at our absolute discretion. Your Application is only accepted when we send you Confirmation.

3.2 You will be sent Confirmation once you have successfully paid for your chosen Short Course or, in the case of a free course, within a reasonable time from receipt of your Application.
